- Strategic thinking: How does ARMTA retain and develop relevance in the music community? Discuss with reference to:
 - the use and recognition of RMT designation have not followed up with Nathan Chan or any attempt to duplicate Saskatchewan legislation protecting RMT brand Beth

We do not have legislation like in Saskatchewan where there are fines established for unauthorized use of RMT. We could try to push for government legislation, but since an acronym is not registerable, we don't think it is worth it.

- ii. develop a strategy for contacting non-RMTs on the RCM teacher list Naomi Naomi did begin to compare the RCM teacher list to the ARMTA list. She got a few names that we could approach. She asked if RCM could share their list of teachers, but they won't. We could also look for potential members with university or college faculty or even by searching Kijiji.
- iii. develop an information package volunteer needed Annette will put together a letter with the existing Benefits of Membership brochure as an information package that could be used to send to potential members.

 Annette & Naomi will work out who and how to send out this information package.

iv. MTNA collegiate model for developing students who would become RMTs

At the college or university level, there would need to be a college or faculty member that acts as a faculty advisor for their club with their own executive. We would need to have a convenor to keep in touch with the collegiate chapters and welcome them to any continuing education workshops, conferences, and other projects. The only drawback or difficulty is that the MTNA model is that anybody can join MTNA but only some are credentialed. The PPG (Piano Pedagogy Group) in Calgary or STAFF in Red Deer would be similar to this collegiate model. There is also a Piano Club at the U of C. The first step to developing this would be to find an ARMTA member at a university/college who would provide incentive and drive to get it going. Potential staff: Patricia Tao or Jacques Despres (U of A), Karen King (U of C), Edwin Gnandt (Ambrose), Milton Schlossar (Augustana).

The average age of a new member joining ARMTA in 2015-2016 is 39.1. The median age is 35.5, so we have not been attracting the new, young teachers. While in some ways this overlaps with sending out the information package, that is focused on teachers who are already teaching and this is focused on new or upcoming teachers.

Marlaine will approach the potential staff mentioned to see if they would be interested in doing this. Finding someone to take on this project will need to wait and/or be combined with Post-Secondary Promotion if there are faculty members interested in taking it forward.

There is a discount code set up for Calgary (CALGARYFIRST) for new members to get their first year of branch membership free. Lethbridge also offers one year of free membership to their new members (discount code: LETHBRIDGE).

viii. <u>Examining Board issues with registered subjects</u> <u>Vicki/Diane Ferguson</u>

Do we want to specialize in studio teachers or be open to those with a Bachelor of Education? Those with a B.Ed are expected to be able to teach anything in the school system.

Our current designations do not recognize teaching experience or those who specialize in elementary levels. Why is it that people are looking to join ARMTA? Are they looking for the continuing ed, the insurance, or something else?

If they are looking to join ARMTA, they should have a studio. We do not want to register in Concert Band. New question to be added to membership application: Are you planning on teaching in a studio? (generally one on one or small groups) (Vicki will refer to Edmonton FESST scholarship application for more exact nomenclature.)

The statement about a "recognized college or university" as a qualification for full membership is clear enough. Annette, Barb, Vicki, and possibly Dale will work out further details to make the application more clear, including a list of registered subjects on the application for new members to choose from. Barb may be interested in joining the Examining Board in a few months' time.

b) Updates to Mission Statement

Our Code of Ethics addresses what it is we promote, but it is quite long. Debbie will draft a succinct mission statement for our next board meeting. Debbie is dissatisfied and not in agreement with everything in the current Code of Ethics, though it was adopted by the ARMTA provincial board and is almost exactly the CFMTA Code of Ethics, and may bring forward possible changes to the next board meeting.

Be pursuing music pedagogical studies – practical, theory, advanced studies, etc,

This scholarship is intended to be open to students who are not studying with an ARMTA teacher.

Beth has drafted a letter to Field Services with Alberta Education with a request for more information about the directives driving the decisions to have more requirements for music teachers. f) SOCAN (Society of Composers, Authors and Music Publishers of Canada) licensing
Michelle

At the Calgary branch, they have their Awards recital recorded and broadcast by SHAW. Because they were looking into recording and selling it on DVD, they contacted SOCAN, who told them that they needed to pay \$35/recital in licensing fees. Churches and schools are exempted, but because ARMTA is not a school, we are not considered an educational institution. Beth has looked into copyright law, which does not specifically address private music education. According to MTNA with ASCAP, most of ARMTA's activities would not need to pay licensing fees. This is definitely a national issue, so to start with, Beth will follow up with Cindy Taylor (CFMTA President) since we have learned that BC has also looked into this. ARMTA will probably need to get legal advice on what to do about this.

One of the things discussed at the February 2016 board meeting was to see if APTA or AMEF would be interested in doing a conference just for studio teachers. Music Conference Alberta (MCA) is focused on classroom teachers, the tradeshow is for classroom, they plan and work on a school schedule, and the keynote is going to be band or choral. AMEF took a brief look at it but didn't discuss it. AMEF needs ARMTA because we bring in more people than any other part of their association.

APTA is not prepared to change what they have with their own conference.

We are feeling the time for MCA may be coming to an end. The board feels it would work better to have miniconferences come to the members in their location. We would need to scale up continuing education, like perhaps:

- An additional day added on to CASSA (Central Alberta SSA in Lethbridge) clinics offered annually.
- Sponsoring sessions with NATS
- Clinicians traveling to different branches, including smaller branches or pockets of teachers.

We still need to have an AGM, which could be attached to a professional development event moved around to different branches. We could also try online meetings.

Beth, Marlaine, and Viktoria will continue to discuss to come up with ideas. This will go near the beginning of the agenda for our February meeting.

6. a) viii. Examining Board issues with registered subjects

With ARMTA applications up until 2012, when applicants were asked what subjects they wished to be registered in, there was a list of subject areas that applicants were asked to check from. It was a long list including subject areas that we would probably not register in anymore but consider subjects taught, such as Kodály and Alexander Technique. With the March 2012 application revisions, the application was simplified greatly. Instead of being given a list of subjects in which they could be registered, applicants were simply asked the open-ended question:

In a separate window it states:

Registration in a SOLO discipline (e.g. piano, violin, voice) requires documentation proving that it is your major area of study.

If your degree/diploma does not state your instrument, please include a copy of your transcript.

If your transcript lists only "practical study" or a general term instead of a specific instrument, other documentation that can be used to show your major(s) may include recital programs (preferably junior or senior recitals as part of your degree), a reference letter from a teacher, recordings, or student recitals and/or exam results.

Evidence of pedagogy certification (study of how to teach) and/or teaching experience is desirable. New applicants are encouraged to provide proof of teaching experience if they have it. It is accepted that Affiliates and those who have just completed a diploma/degree may have little or no teaching experience.

For registration in THEORY (e.g. Advanced Theory, including Harmony and History, Composition, Pedagogy), a diploma or degree in this area is required. Otherwise these can be listed as "Subjects Taught."

Registration is not granted in Rudiments since every Full member is qualified to teach Rudiments.

Even with examples of the distinction between registered subjects and subjects taught, we have seen over the past year requests for registration in subjects that are neither solo disciplines nor theory such as Music Education, Early Childhood Education (Dalcroze), and Concert Band.

In one recent example, we had an applicant with a Master of Music in Music Education, a Bachelor of Arts degree, a Bachelor of Education with a major in Music Education degree, and an RCM Grade 8 piano certificate. They requested registration in Advanced Theory, Harmony, Pedagogy, Percussion, Concert Band with additional subjects taught of Jazz, Brass, Woodwinds, and Steel Pans. When asked to narrow their requested registered subjects down, they requested Concert Band and Pedagogy. Their master's transcript indicated that they had

studied music theory, but no specific instrument, which according to their undergraduate degrees was music studio classes in percussion.

In another example, we had an applicant with a degree from the Instituttet for Rytmik in Denmark, a full-time 3-year college program that granted the equivalent of a North American Bachelor degree in Dalcroze Eurhythmics. They requested registration in Early Childhood Education.

As put by Dale Wheeler:

It is somewhat disingenuous to encourage people to apply for ARMTA membership, ask them to list the areas in which they wish to be certified, and then proceed to say "Well, actually you can't be qualified in this area" or "You don't have the necessary training in that area." It makes us look foolish.

Once we get into approving areas that are more ensemble directing than studio teaching it becomes a slippery slope. The heart of ARMTA is the studio teacher — our web presence and all our promo materials tacitly (or not so tacitly) support that goal. Band and Choir directors have ABA and ACF and many are also part of ATF. Studio teachers ONLY have ARMTA. So, one part of me wants to narrow the focus of registration by stipulating some clear subject areas that are more specifically related to teaching "an instrument/voice", something we traditionally associate with ARMTA. Another part of me realizes the need for inclusiveness and the desire to attract more members.

We have also noticed a growing trend towards members requesting registration in Theory or Advanced Theory or other theoretical subjects, and an increasing trend towards applicants not having associate diplomas or conservatory certificates but instead having B.Mus degrees, B.A. degrees, or B.Ed degrees. With degrees other than a B.Mus, even with a transcript it is often difficult to establish their level of proficiency to determine whether they should be given Affiliate Grade 9 or Grade 10 membership or whether they might not even have a Grade 8 equivalency.

There are some areas in which the examining board needs the direction of the board.

- 1. Historically, ARMTA's focus has been on private studio teaching rather than classroom music teaching. There is, however, nothing in the bylaws or Policies & Procedures manual including our Mission Statement or Objectives that explicitly states whether that was or should be the intention. Would we like to keep our focus narrow on studio teachers, or should we include music educators who have a bachelor's degree in music education focused on early childhood, elementary, or high school music education with registration in Music Education, School Music, Concert Band, or something similar?
- 2. On the application and in our Policies & Procedures it states that one of the requirements that can be used for full membership is "d) employment in a teaching capacity in the Music Department of a recognized College or University." We had a recent applicant submit contracts with Mount Royal University Conservatory to this end. Since we believe the intention was to include faculty members in degree-granting programs rather than contract teachers, even though they may be involved with well-respected institutions such as Mount Royal Conservatory or MacEwan Conservatory, we wondered if this needs clarification, which would mean an alteration to Policies & Procedures and the application form.

With these broad issues narrowed down somewhat, we would suggest that a committee struck by the board work more specific details, including:

- More specific guidance for applicants on which subject areas are available for registration, including perhaps what qualifications are necessary for specific areas.
- Whether we can offer applicants with a B.A. in Music a minimum Affiliate Grade 9, since they have postsecondary studies in music, or continue to request that they provide documentation showing their performance abilities such as conservatory exam results, recital programs, or jury results and look at their transcripts for music courses to try to determine their equivalent to an RCM grade level.
- There are a few odd registered subjects that have cropped up, such as Accompaniment, Chamber Music, Instrumental Conducting, Suzuki Method, and Music Therapy. Should these be eliminated as Registered Subjects and instead be relegated to Subjects Taught, should they kept for those already registered in them but not for future applicants, or should we continue to register members in them?
- We understand that there has been a request for existing teachers to be able to be registered particularly
 in advanced theoretical subjects based on proven successful teaching experience, such as with providing
 student exam results. How much experience would be needed?

9 <u>Back to Top</u>

Because there is an inter-provincial transfer agreement between RMT associations, we need to be aware that whatever decisions we make have the potential to affect other RMT associations when our members transfer their memberships. The one member we currently have registered in Early Childhood Education is because they transferred their membership from Ontario with that registered subject. The only province with specific guidelines available as to what is required for specific areas of registration is Ontario (http://www.ormta.org/become-a-member/membership-requirements) who registers members in Early Childhood Music and School Music with a Bachelor of Music Education degree.

6. c) Post-Secondary Pedagogy Scholarship

ARMTA Pedagogy Scholarship Pedagogy Scholarship from the ARMTA Recognition Fund

Purpose: The ARMTA Pedagogy Scholarship of \$1000 is offered to assist students, at an advanced level, who wish to further their musical studies through the pursuit of pedagogy. The basic requirements are:

- · commitment to music study and teaching
- academic scholarship

Description of the Pedagogy Scholarship:

- One award is available each September 30th in the amount of \$1000 per recipient.
- Applications are reviewed and scholarships are awarded on a yearly basis.
- Applicants enrolled in any Pedagogy study are encouraged to apply.

Applicants for the ARMTA Pedagogy Scholarship should meet the following criteria:

- Be a permanent resident or citizens of Canada;
- Be a resident of Alberta for at least 6 months or be studying with a teacher in Alberta;
- Be pursuing music studies in any music genres practical, theory, advanced studies, etc,
- Have a desire to continue to share their musical talent through teaching.

How the Pedagogy Scholarship is awarded:

- A committee designated by the ARMTA Provincial Board will review applications each August. The
 decision of the committee is final.
- All cheques from the ARMTA Recognition Fund are made out in the name of the student/recipient. They
 cannot be made out to an ARMTA member, to the parents, to an institution of learning, or to the instructor
 of the student.

Applying for the ARMTA Pedagogy Scholarship:

6. d) Alberta education and private music study

A 12 42 . . N.1

On June 13, we set up a petition on Change.org. With every signature, a copy of the hard copy letter previously given to members to send in to David Eggen, Minister of Education, was emailed to both Mr. Eggen and Ms. Rachel Notley, Premier. A link to this email was emailed to our members, and it quickly had the attention of Mr. Mike Emery, Director of PASI and Student Records with Alberta Education, who called us on June 17. Initially, there was much confusion as Alberta Education claimed that post-secondary institutes (PSI's) were accepting RCM or CC transcripts in lieu of having the marks reported on the Alberta transcript. While some PSI's had confirmed they would accept RCM or CC transcripts where the course was directly applicable to the program they were applying for, none indicated that they could consult external transcripts to use the mark for a fine arts credit for general admission. The change had been made to make it clear to post-secondary schools which credits had been received directly through Alberta Education courses for which they could be responsible for what marks were received and which courses had been taken "out of province" for which they didn't want to take responsibility. While it was geared towards solving a problem with programs like sports programs or

homeschooling giving high marks which they did not deserve, penalizing private music study became an unintended consequence.

Updates posted to the Change.org petition and to our members:

23 JUN 2016 — Thank you for your support for Alberta students receiving full credit with a mark for private music study! To date, we have had 389 people sign our petition, which has been enough to attract the attention of Alberta Education. We have been contacted by the Director of PASI and Student Records with Alberta Education. They have agreed to meet with ARMTA to better understand our arguments and to explain their rationale for the changes that have been made to date. There are also conflicting reports from post-secondary institutions that we each wish to clarify. We look forward to updating you with further information and developments!

28 JUL 2016 — ARMTA executive and committee members met by conference call on July 8th with the Director of Student Records of Alberta Education and other representatives of Alberta Education. Our primary concern, to have the mark portion for Music 10, 20 and 30-level private music reinstated, was discussed, and Alberta Education informed us they will look into possible solutions.

As of April 2015, RCM and CC credits are listed on the Alberta transcript under "Other Credits" with the number of credits but no mark. We are aware under the present circumstances that this could cause students difficulty with their applications to post-secondary institutions, even if private study courses were completed prior to the decision.

If you or any Alberta student that you know of are experiencing difficulty because of how the evaluated credits for Music 10, 20, or 30 are being handled, particularly with regard to post-secondary admission, please contact the Student Enrollment and Marks Unit within Alberta Education Student Records at 780.422.9337 for assistance.

2 SEP 2016 — We are very pleased to inform you that ARMTA has received a letter from Curtis Clarke, the Deputy Minister of Education, who let us know that Alberta Education has agreed to restore marks received for private music study to the Alberta transcript! To quote from his letter: "Alberta Education is aware that there are inconsistencies in the way the percentage mark is averaged or considered between admissions, specific faculties, and between post-secondary institutions. For this reason, we are proceeding with a change to the Guide to Education to include a percentage mark when Alberta principals evaluate private music study. Going forward, the Alberta transcript will report this percentage mark alongside the credit awarded in a new Private Music Evaluations section of the transcript. The percentage mark will be reported as an evaluated mark. This change will support accuracy and clarity in reporting of Alberta curriculum, while providing a mark for post-secondary consideration."

We are optimistic that this solution will work well for our students. We look forward to clarifying further details with Alberta Education and implementation of this plan.

11 OCT 2016 - ARMTA is pleased to report that another meeting was held with Alberta Education regarding the reinstatement of marks for private music study. We can confirm that a new "Private Music Evaluations" section will be added to transcripts, with courses showing as "Choral Music and Instrumental Music 10, 20 and 30." In cases where a higher level course has been evaluated and awarded credit and a mark, any lower levels which are not included on the Royal Conservatory of Music or Conservatory Canada transcripts will be listed in the existing "Other Credits" section of the Alberta transcript without a mark. The percentage split will be evaluated as a combined mark of 70% Practical and 30% Theory as in the past.

High School principals will receive an addendum to the Guide to Education this fall informing them of these changes, and system changes to allow the submission of a mark are expected to be completed by the end of November 2016. We will also be notified once these system changes are complete and students can then proceed to submit their Royal Conservatory of Music or Conservatory Canada transcripts to their principal for evaluation. Students who previously received credit without a mark after the 2015 decision may also have their records updated at this time or in the future. Mark submissions will be included on transcripts starting in February 2017. If it is mandatory that a student receive their mark for post-secondary applications prior to this date, please contact Mike Emery, Director, PASI and Student Records at mike.emery@gov.ab.ca or 780-427-6930.

We are grateful to Alberta Education for making these changes and giving our private music students the credit they deserve!

Does ARMTA have a responsibility to keep post-secondary schools up to date on the RCM and Conservatory Canada requirements for grades/levels 6, 7, and 8 that may be used for high school credits? Refer to Naomi Parker's email of July 11 with respect to Concordia, however, it just goes to show that there is no good communication somewhere....maybe ARMTA could be more proactive in informing institutions of these changes. 7. a) i) Updated email voting procedure

REMOVE FORMER VOTING PROCEDURE:

- 18. E-mail Voting will occur only in the most urgent of situations. It is imperative that members confirm immediately that they have received communication at each stage. Written e-mail responses are necessary for record keeping. Should an urgent issue come to the attention of the President (or the Vice-President in the absence of the President) the following steps will occur:
 - a. The President will explain the issue by e-mail, will request a reply to confirm receipt of the message and will request that a motion be made. If no reply is received within 24 hours the President will follow up with phone contact.
 - b. When a motion has been made, the President will inform the board of the motion and request that someone second the motion within 24 hours.
 - c. When the motion has been seconded, the President will advise the board members that they have 48 hours to "Reply All" and discuss the issue.
 - d. After 48 hours, the President will call for an e-mail vote. There are three options: In favor, opposed, abstain. Any members who have not voted within 24 hours of that call for a vote will receive a telephone call from the President encouraging them to reply immediately.
 - e. The motion will be decided by a simple majority of the Board Members.
 - f. The President will notify the Board Members of the result as soon as it is determined.

ADD PROPOSED NEW VOTING PROCEDURE:

- 18. Between regular board meetings, occasionally a matter arises that cannot wait for the next board meeting. In such cases, the president shall call a special meeting of the board, including the administrator who will keep a record the meeting for the next board meeting minutes. If via a medium like email, the president will

II. CANADIAN FEDERATION OF MUSIC TEACHERS' ASSOCIATIONS

Election of ARMTA members to the CFMTA Board is provided for as follows:

- 1. ARMTA members may be nominated and elected to serve on the CFMTA Board for a term of up to six (6) years in the capacity of 3rd Delegate, 2nd Delegate, and 1st Delegate. An additional term may be allowed if the Provincial CFMTA 1st Delegate becomes CFMTA 1st Vice-President.
- 2. All CFMTA delegates must have served a minimum of two (2) years on any Provincial Board, as a Board Member or Convenor. A CFMTA Delegate may simultaneously hold any current ARMTA Board position. Unless exceptional circumstances occur, ARMTA Provincial Delegates to CFMTA will hold the following positions on the Provincial Board: 1st Delegate ARMTA Past President; 2nd Delegate ARMTA President; 3rd Delegate ARMTA Vice President.
- 3. The rotation of CFMTA delegates will be from 3rd Delegate (ARMTA Provincial Vice President) to 2nd Delegate (ARMTA President) to 1st Delegate (ARMTA Provincial Past President) and shall be automatic after having once been nominated and elected as 3rd Delegate (ARMTA Provincial Vice President).
- 4. When either the Provincial CFMTA 1st Delegate or the 2nd Delegate is unable to carry out his/her responsibilities, the 3rd Delegate shall assume the delegate's role from that point forward unless special dispensation has been granted by the ARMTA Board.
- 5. If a 1st or 2nd Delegate is unable to fulfill their obligations, and the 3rd Delegate cannot assume the responsibility, the Provincial Board will appoint a temporary (acting) 3rd Delegate replacement.
- 6. CFMTA delegates serve on the Provincial Board and attend all meetings, will vote as instructed by the ARMTA Board with the provision that having heard all discussions they should be free to make amendments and vote accordingly.
- 6. CFMTA delegates serve on the Provincial Board and attend all meetings.
- 7. CFMTA delegates will present CFMTA resolutions to members of ARMTA board for direction. They will vote as instructed by the ARMTA Board with the provision that having heard all discussions they should be free to make amendments and vote accordingly.
- 7. Each delegate shall provide full reports to the Board and the Branches of all CFMTA business.
- 8. The first delegate, in consultation with the 2nd delegate, shall provide a full report to the Board of all CFMTA business. The Branch representatives should carry the report to their branches.
- 9. CFMTA pays travel expenses for the National President to attend ARMTA's Annual General Meeting. ARMTA pays the balance of the expenses.
- 10. CFMTA delegates are encouraged to serve on a CFMTA committee during their tenure.

CFMTA 1st Delegate (Provincial Past President)

The CFMTA 1st Delegate serves as the liaison between CFMTA and ARMTA on all matters of mutual concern. This will include providing CFMTA with information generated from local opinion. When such information is requested, the CFMTA 1st Delegate must contact the President of ARMTA after which time, contact might may be made with Board Members and Branch Presidents. The CFMTA 1st Delegate must at all times use discretion in voting and not rely on his/her own opinion in matters of wide concern, but vote the wishes of the Provincial Board.

Further Specific Duties of the CFMTA 1st Delegate

1. Bring Special Resolutions from ARMTA to CFMTA.

- 2. Write the Alberta Provincial Report for the CFMTA Executive Meeting which is also published in the spring issue of Canadian Music Teacher.
- 3. Attend the CFMTA National Convention and General Meeting and the CFMTA Executive Meetings in the non-convention year.
- 4. Prepare an annual report for the CFMTA to be given at the General Meeting in convention years and at the CFMTA Executive Meeting in the interim years.
- 5. Prepare a full report of CFMTA business and activities for the ARMTA Annual General meeting and Provincial Board meetings.

The CFMTA First Delegate shall act in accordance with CFMTA policies and procedures, specifically as regards the section "Provincial and Territorial Delegates".

In addition, the First Delegate will:

- 1. Bring Special Resolutions from ARMTA to CFMTA
- 2. In consultation with the 2nd CFMTA delegate, prepare an annual Provincial Report for the CFMTA annual Executive Meeting.
 - a. Gather news items from the branch reps and from their reports.
 - b. Seek items that reflect all areas of the province, that focus on music, opportunities for students, professional development for teachers
- 3. Attend CFMTA annual Executive Meetings and Annual General Meeting, and in convention years, attend the CFMTA National Convention.
- 4. In consultation with the 2nd delegate, prepare a report of CFMTA business and activities for the ARMTA Provincial Board meeting and the ARMTA Annual General Meeting.

CFMTA 2nd Delegate (Provincial President)

- 1. Prepare Provincial news reports for the CFMTA Newsletter using Provincial Branch reports.
- 2. It is expedient to have Branch Newsletters mailed to the 2nd Delegate; however, if not available, the 2nd Delegate is to contact the Branch Presidents. 3. News reports for CFMTA must be of a business nature and related to musical activities and not a report of social affairs.
- 4. It is important that news reports cover the entire province and not one area only.
- 5. Attend Branch meetings and provide rapport with that Branch and CFMTA.
- 6. Attend the Provincial Conference and accompanying Executive meetings and CFMTA meetings at the National Convention-
- 7. Prepare an article for the fall issue of the newsletter (Tempo).

The CFMTA 2nd Delegate shall act in accordance with CFMTA policies and procedures, specifically as regards the section "Provincial and Territorial Delegates".

In addition the 2nd Delegate will:

- 1. Assist the 1st CFMTA delegate with reports to and from CFMTA.
- 2. Attend CFMTA annual Executive Meetings and Annual General Meeting, and in convention years, attend the CFMTA National Convention.
- 3. Prepare an article for the summer issue of TEMPO: highlights from CFMTA meetings, services and programs provided by CFMTA.

We received the following letter from Kathleen Seutter, one of our members:

I have received a request from The Centre for Learning@Home to complete a service provider application for home school funding for one family I teach piano lessons to. It states in the request that these regulations are implemented due to new directives from Alberta Education.

As a qualified and experienced piano teacher, I am totally committed to providing a safe and caring learning environment for ALL the students I teach, and have absolutely no issues with providing a criminal record check, or ensuring that students have lessons in a safe environment. However, I do have questions and concerns regarding the following three items.

- 1. The Site Inspection Requirement
 - a. I teach 4 home school families. They are all with different home school associations. Will I be subject, then, to inspections by four different agencies every year? This seems to be an onerous invasion of my privacy, particularly in view of the fact that my place of business is also my home.
 - b. If I teach the children in their own home, will their home also be subject to inspection?
 - c. Are parents not to be trusted with choosing a safe piano teacher/environment for their own children? Is an outside inspection necessary when, as in this case, the parent has been in my home every week with her children for the past four years, and certainly would have more sense of the safety of her children and my home than any outside party?
 - d. When parents come to interview me as a piano teacher, I assume that one of their primary concerns is the safety of their children. Do you not trust home school parents, or any parent, to ensure that their piano lessons are held in a place of safety?
 - e. Parents are welcome at all times to be present during the lessons. Is the site inspection requirement undue interference by the government in the private lives of its citizens?
 - f. I am unaware of any incidents at piano lessons. What prompted this requirement?
 - g. I have no issue with the site requirements. Is it, however, the role of government/educational institutions to inspect piano teachers' homes? I think that, if necessary at all, it would more properly be the role of a professional organization for piano teachers, such as the Alberta Music Teachers' Association.
- 2. The Limitation of Choice for home school families and the quality of instruction provided to students.

Home school families may only receive funding if they take lessons with a "preferred service provider." As a professional piano teacher I have the following qualifications:

- Two Bachelors' degrees in Music and Education
- A.R.C.T. in Piano Pedagogy from the Royal Conservatory of music, for which I received the highest mark in Canada.
- A.R.C.T. in Piano Performance
- Professional Teaching Certificate in Alberta
- Twelve years experience teaching in the public education system.
- Fifteen years experience teaching piano
- Students of mine have won awards at Local and Provincial Music Festivals, as well as for top marks on Royal Conservatory exams.
- Membership in several professional organizations, including the Alberta Registered Music Teachers' Association (ARMTA), which also provides \$5,000,000 liability insurance for all aspects of my business.

Even though I am a very qualified teacher, would home school students who study with me not be reimbursed for funding if I don't agree to a home inspection because I trust that parents are more concerned for the safety of their own children than any government institution is? And would home school

children receive funding for studying with a far less qualified teacher who agrees to the site inspection? How is this in the best interest of the education of the child?

3. The Right of Professional Organizations to Govern their Members

When I taught in the public school system, the Alberta Teachers' Association required from me the professional qualifications and conduct of the teaching profession, and also recourse for me regarding evaluation of my professionalism.

As a piano teacher, I feel that my membership in the Alberta Music Teachers' Association required me to meet the rigorous requirements of the profession, and that ANY student who studies with me should be confident of my professionalism and that they are entering into a safe, caring, and valid learning environment.

- As a stakeholder whose members will be greatly impacted, was ARMTA consulted in any way before these directives were put in place?
- Should not membership in ARMTA give any parent or organization confidence that they are studying with a competent teacher in a safe environment?
- Should it not be the governing professional organization, in this case ARMTA, which puts in place requirements for the profession?
- Should not membership in a professional organization such as ARMTA be an umbrella certification that would guarantee qualification to all parties and all educational institutions across the province, without me having to go through separate qualification for every home school association?

My membership in ARMTA ensures that I have met standard criteria for my profession, and also provides me with \$5,000,000 liability insurance in all aspects of my business, whether on site or off site. Why should this be duplicated many times over by asking me to register with individual school associations, repeatedly supplying the same information? I strongly feel that this is creating a huge amount of needless bureaucracy and paperwork on the part of the government and that it is not an effective use of the taxpayers' dollar.

Line 370 Federal Children's Arts Amount Tax Credit (CATC) Reduced for 2016, eliminated for 2017 taxation year

Income Tax Act s. 118.031, Regulations s. 9401

The 2011 Federal Budget introduced this <u>non-refundable tax credit</u> starting in 2011. The legislation is included in <u>Bill C-13</u>, which received Royal Assent (became law) on December 15, 2011. The <u>2016 Federal Budget</u> proposes to *reduce the 2016 Children's Arts Amount Tax Credit* to \$250 from \$500, and *eliminate this credit for 2017* and later years. The additional tax credit for a child with a disability will remain at \$500 for the 2016 taxation year.

This tax credit is available to individuals for registration and membership costs of up to \$500 per child, for prescribed programs of artistic, cultural, recreational or developmental activity for their children who are, at the **beginning** of the taxation year

- under 16 years of age, or
- under 18 for a child with a disability (i.e., when any person is able to claim a disability amount tax credit for the child on line 318 of the federal tax return)

The tax credit is calculated using the lowest tax rate of 15%, so the maximum tax credit per child will be \$75. An *additional tax credit* is available to an individual for a *child with a disability*. The additional credit is \$500 x the lowest tax rate, if the total of eligible costs for that child in the year is \$100 or more. This brings the maximum tax credit to \$150 for a child with a disability.

Example of calculation of children's arts tax credit for 2011 to 2015 taxation years:

| Total cost for prescribed programs for the child | | \$100 | \$200 | \$300 | \$400 | \$500 | \$600 |
|-------------------------------------------------------------|------|-------|-------|-------|-------|-------|-------|
| Children's arts tax credit @15% to maximum \$75 | \$12 | \$15 | \$30 | \$45 | \$60 | \$75 | \$75 |
| Additional tax credit for child with disability \$500 x 15% | 0 | 75 | 75 | 75 | 75 | 75 | 75 |
| Total tax credit for child with disability | \$12 | \$90 | \$105 | \$120 | \$135 | \$150 | \$150 |

The tax credit may be claimed by either spouse, or apportioned between them.

Eligible programs include the following, which are not part of a school's curriculum:

- a. a weekly program of 8 or more consecutive weeks in which all or substantially all of the activities include a significant amount of artistic, cultural, recreational or developmental activity;
- b. a program of 5 or more consecutive days, if more than 50% of the daily activities include a significant amount of artistic, cultural, recreational or developmental activity;
- c. a program of 8 or more consecutive weeks, offered to children by an organization where participants in the program may select from a variety of activities if
 - i. more than 50% of the activities include a significant amount of artistic, cultural, recreational or developmental activity, or
 - ii. more than 50% of the time scheduled in the program is scheduled for activities that include a significant amount of artistic, cultural, recreational or developmental activity
- d. membership in an organization for 8 or more consecutive weeks if more than 50% of the activities offered to children by the organization include a significant amount of artistic, cultural, recreational or developmental activity
- e. for a program of 8 or more consecutive weeks, which does not meet the 50% requirement of (c) above, offered to children by an organization where participants in the program may select from a variety of activities, **the portion**
 - i. that is the percentage of those activities that include a significant amount of artistic, cultural, recreational or developmental activity, or
 - ii. that is the percentage of time scheduled in the program that is scheduled for activities that include a significant amount of artistic, cultural, recreational or developmental activity
- f. for membership in an organization for 8 or more consecutive weeks, where the 50% requirement of (d) above is not met, **the portion of membership** that is the percentage of all the activities offered to children by the organization that are activities that include a significant amount of artistic, cultural, recreational or developmental activity

Artistic, cultural, recreational or developmental activity means a supervised activity suitable for children (other than a physical activity) that

- is intended to contribute to a child's ability to develop creative skills or expertise, acquire and apply knowledge, or improve dexterity or coordination, in an artistic or cultural discipline including:
 - literary arts,
 - o visual arts,
 - o performing arts,
 - o music,
 - o media,
 - o languages,

- o customs, and
- o heritage:
- provides a substantial focus on wilderness and the natural environment;
- assists with the development and use of intellectual skills;
- includes structured interaction among children where supervisors teach or assist children to develop interpersonal skills; or
- provides enrichment or tutoring in academic subjects.

The cost of accommodation, travel, food or beverages are not included.

Any costs which qualify as <u>child care costs</u> must first be claimed as child care costs, with the remainder of eligible costs then claimed through the arts credit.

Any costs which qualify for the Children's Fitness tax credit cannot be claimed for the Children's Arts credit.

There was a possible issue in Calgary about this a few years ago. Also, is it OK to compete in the ARMTA competition more than once?"

Dale Wheeler email July 26: "My thought: the only requirement is that a competitor is a student of an ARMTA teacher. There is no stated rule that a competitor cannot also be an ARTMA member. Perhaps this topic is something that needs to be discussed at the Board level for future years, but for this year I think the decision is clear-cut."

The area of publicity has yet to have a convener. I feel strongly that ARMTA needs to do more to publicize and develop a reputation for quality music education among families seeking private music education. If families are seeking RMTs, good music teachers will want to be ARMTA members. Good teachers will enhance the reputation of ARMTA.

Last fall it came to ARMTA's attention that Alberta Education was no longer giving a numerical mark for private music study on high school transcripts. On behalf of ARMTA, I wrote a letter to Minister of Education David Eggen explaining our disappointment and requesting a return to including a numerical grade. I want to thank Marie Gazzard, Naomi Parker, and Vicki Martin who have spent countless hours following up and lobbying on behalf of all private music students wishing to use their exam marks on their high school transcripts. Thanks to everyone who supported them with petitions and letters. At time of writing, we seem to have been successful in restoring a numerical mark on high school transcripts, and are in the process of clarifying how the mark will be determined and where it will appear on the transcript.

As my term as president draws to a close, I want to thank Vicki Martin for her energy, efficiency, and time she spends supporting the president and our association. We can accomplish so much for our students when we work together. It is time well spent growing skills in leadership and communication, and in growing relationships with colleagues.

First CFMTA delegate, Karen MacDonald, and second CFMTA delegate, Beth Olver, attended CFMTA meeting in Toronto July 5-7, 2016 along with delegates from each province and Yukon.

Branching Out 2017: Happy Birthday Canada! This project will run during the calendar year January 1, 2017-December 31, 2017. A \$100 subsidy will be available to all RMT Branches for a Happy Birthday Canada onetime event within the calendar year.

CFMTA MTNA joint conference March 18-22, plus pedagogy Saturday, March 18

MTNA has agreed to give CFMTA 30% of registration fees paid by CFMTA members. CFMTA has agreed to divide this amount: 40% to CFMTA and 60% to the provinces (prorated by number of registrations from each province).

CFMTA executive officer meeting will be Thursday March 16, 2017 in Baltimore and the annual board meeting on Friday March 17, 2017. MTNA is providing meeting rooms.

The 2019 conference host is Manitoba RMTA.

Canada's 150 Birthday: To mark this occasion, CFMTA annual "Call for Compositions" will result in a unique compilation of music by **Canadian composers**, works suitable for performance by musicians of various levels of ability, published in electronic format with scores available as free download via CFMTA.org. At the Baltimore conference, MTNA members will be offered the collection as a gift from Canada.

CFMTA financial records are once in again in good order thanks to hours of diligent forensic back checking from the finance committee and the current treasurer and bookkeeper. Lois Kerr has become the treasurer, recombining the treasurer and bookkeeper duties.

CFMTA fees will be raised for the first time in more than a decade. Beginning 2017-18 fiscal year the fee will be \$30. CFMTA has consistently had a significant budget shortfall over each of the last four years and there is no reason to believe this trend would change given increased costs for hotels and fair compensation for paid staff (secretary and treasurer). Since the fee is included in ARMTA provincial fees, ARMTA needs to determine whether the \$4.00 increase will be shown in our provincial fees beginning in 2017.

The **Translation Committee** will seek Federal Government Grants to support translating the Policy and Procedure manual into French. This is the last major document to be translated.

CFMTA is investigating using a professional consultant to help with strategic planning.

For the past five years **The Personal Insurance** has been a sponsor of CFMTA. The chief benefit has been \$6000 first prize award in CFMTA piano competition. The relationship is up for renegotiation. They have been disappointed in the number of RMTs that have taken insurance plans from them, and in the provincial boards' unanimous decision not to give them access to our membership lists. Charline Farrell is continuing to negotiate with them.

The cancellation/phasing out of **CATC** was considered. The provincial boards will be polled about their level of concern.

RCM teacher certification program: President Cindy Taylor and Past President Charline Farrell had a conversation with the academic department of RCM re: the certification program. The provinces are not in agreement in their views about this program.

The delegates from Yukon talked to Alberta and BC delegates about possibly extending our Young Artist Tours with a stop in Whitehorse.



This was the first year that we offered online payments for membership renewals. We guessed that about half would pay online. Of the 413 members who had renewed by May 16th, the following number of members paid in the following ways:

This was also the first year that we asked members to give us their year of birth. It was required for anyone who renewed online, and while it was included on the paper renewal form, many members didn't notice and didn't add it. In the end, we got year of birth information for 309 of those 413 members, which means we don't have complete data (and it may be that those that renewed by paper and skipped it are also the older members, so take this all with a healthy dash of skepticism) but more than enough to be reasonably accurate. Of those members, we have the following number of members born each year:



It may also help to see it somewhat averaged out over each five-year span:



As you can tell and probably to no one's surprise, our biggest bubble is born between 1950-1965, which is 51-66 years old and soon to retire – although music teachers are known to keep teaching beyond what would normally be considered retirement age! Reassuringly, there is another smaller bubble in the 1975-1985 (31-41 years) as well, so there is another generation coming up behind.

Overall, the average ARMTA member is 51.6 years old. The median age is 54, which means that half of our members are over the age of 54 and half are under the age of 54.

We touched on it briefly at our last board meeting, but this is the number of members with each registered subject out of the total 413 members. There is some overlap, since some members are registered in more than one subject. We are by the vast majority a group of piano teachers.

8. f) Financial report

As of October 3, 2016, ARMTA is in a very sound position financially. Full details are below in the Profit & Loss Statement and the Balance Sheet for the current fiscal year, of which there are a few things worth noting:

- 1. With almost \$50,000 in cash in our chequing account and an expected \$26,501 worth of expenses still to be paid out for this year, we could set aside up to \$20,000 in short-term GIC's and still maintain cash flow.
- 2. To the best of my knowledge, it is working well to have online payments collected by provincial and distributed to the branches about once a month by cheque.
- 3. There were several categories renamed to better reflect our current budget. The Piano Competition was renamed the Piano, Strings, & Voice Competition and the separate Vocal Competition Entries income category was made inactive. CASSA has been placed into a Partnerships Category rather than being included in scholarships since the \$500 annual donation we make does not go towards scholarships.
- 4. In our last fiscal year ending March 31, 2016 we ended with a profit of \$4,556.56 even though we had budgeted a deficit of \$-2,324.90. Much of this can be attributed to an additional \$2,219 received for Sponsorship (formerly Advertising) revenue, \$2,357.90 in additional membership income, and a \$1095 donation. However, on the other side, there was also \$2,635.17 that was budgeted to be spent on projects and services that went unspent, most notably in Continuing Education (\$1,083.54) and the Vocal Competition (\$750) which never materialized. Website hosting was overspent by \$695.39, but this is because they were offering a deal for a three-year hosting plan at a lower rate before rates were increased, so our website hosting is already paid for the next three years.

5. In our current fiscal year, most of our budget has not yet been spent. The Student Composer Competition had both greater expenses and greater income because of the higher number of students participating. The Piano, Voice, and Strings Competition is not expected to spend quite a bit of their budget since the Vocal & Strings component won't be running this year. If you've got money available in your budget, spend it! It does not benefit our members to "save" their money and not use it for projects & services.

8. g) Administrator's report

The society's annual return was submitted to Corporate Registry and they have acknowledged that it has been received and filed.

Updates are going out to provincial members about once a month (more or less frequently depending on the amount of news and relevant dates) by email using MailChimp. I prefer not having hard dates or deadlines and hope that this continues to work for the rest of the executive.

Hours worked averaged 44.4 per month over the October 2015-September 2016 period, slightly less than the 47.0 hours per month for the prior year period. Hours dropped significantly in March and April which can be attributed to efficiencies with online payments and renewals, including not sending hard copies of renewal forms to the branches. There is no single attributable reason for the drop in September hours.

9. e) Canada Music Week

Programs under the Canada Music umbrella include: the national Essay Competition, Student Composer Competition, William Andrews Awards, and Call for Compositions.

The national Essay Competition continued to attract strong interest. The Competition was promoted through an email campaign and mailout of posters to post secondary institutions. William Andrews continues to be a great supporter of Canada Music week, and generously donates two awards of \$250 to support Canada Music Week projects at the branch level. The recipients in 2015 were the Kitchener-Waterloo and Swift Current Branches. The entry deadline for the William Andrews award is October 15.

CFMTA celebrates Canada's 150th Birthday in 2017 with a unique compilation of music, to connect with our past, celebrate our cultural diversity and build a legacy for the future. CFMTA invites Alberta composers to create original musical works that explore new ideas, and interpret and reflect the Canada we live in. We encourage works for musicians ranging from beginner to advanced, with the ability to appeal to a diverse audience.

9. g) Conference 2015/2016

Our clinicians for Music Conference Alberta 2016 October 20-22 at the Banff Centre are Greg Chase (Regina) and Luca Buratto (Italy). Greg Chase is presenting two sessions each on "Cracking the Boy Code" and "When the Volcano Erupts" on Friday and Saturday for a total of four sessions. Luca Buratto presents a masterclass for advanced piano on Friday for a total of 75 minutes.

ARTMA pays clinicians \$250 for each one-hour lecture session, plus expenses including one night's hotel. Clinicians are able to attend the conference without cost. AMEF (Alberta Music Education Foundation), ACF (Alberta Choral Federation) and ABA (Alberta Band Association) cover the facility and promotion costs.

We hope that ARMTA members will also find many other inspiring speakers at MCA 2016.

9. n) Publicity

Note from the administrator: Since there was \$200 budgeted for online advertising and nobody else is looking after publicity, I started looking into and set up a Google AdWords account with a budget of \$2 a day from June 8 through to July 18, which over about eight weeks got us 33630 impressions (which meant that we showed up on a webpage that many times), but only 128 clicks. A total of \$79.78 was spent on this campaign. I should not have done so without further involvement of the board or executive. Between feeling the need to get more advice on how to set up AdWords effectively (since optimizing keywords and bids can be rather complicated) which I've been unable to obtain so far, and my own lack of conviction that it's particularly effective, no further action has been taken.

If we are going to spend any money on online advertising, Google AdWords is probably the way to go. Both Facebook and Kijiji offer their own online advertising, but both have a \$5/day minimum budget. (For Kijiji, each branch could put up their own ad for free to however much they wanted to spend, but to have an ad in multiple cities, then you either have to use Kijiji's aforementioned \$5/day advertising or if we want to be considered one of the "Sponsored Links" like at http://www.kijiji.ca/b-music-lessons/edmonton/c86l1700203, then we actually use Google AdWords to get there.) If we really want to dive in to the world of online advertising, we're probably going to need more than \$200/year, but I had felt that June through summer was the best time to be doing it. 9. o) Social Media

Since going live last spring our number are as follows: Facebook Public Profile – 75 page likes Facebook Closed Group – 38 members Twitter – 11 Followers

I've linked the Facebook and Twitter accounts so that posts made to one will show up immediately on the other. Our closed group is getting good traffic among the included members with lots of quality interactions while our public profile has been averaging around 30 views per post. Our most impressive post being about the issue of marks from private lessons appearing on transcripts, which amassed over 2500 views and had 25 shares.

I'm continuing to look for ways to increase traffic on all fronts. One way to increase the spread of visibility would be to add a budget for boosting posts so that they are placed in the news feeds of most people. Also having people submit information that they would like to be made public on our page would help balance content and provide more interaction with the community.

9. q) Tempo

Since Tempo turned into an annual publication with colour cover; we have received a lot of wonderful feedback. Thanks to our outstanding contributors, we have published some high-quality articles. This year with Amber Rose's hard work, we were able to secure a decent amount of advertisements to generate revenue for our journal.

That said, several challenges remain with the production of Tempo.

- (1) Colour printing, especially the front cover design continues to be a big challenge. It involves getting the best resolution photos in a style that's suitable for a front cover, finding the right photo and using Photoshop for touch up (you may have noticed that Peter Jancewicz's photo in the recent issue has been transformed with an artificial reflection at the bottom; this requires hours of work). Another problem is that the inside black and white printing affects the quality of the colour design. I am hoping that we could either print the entire journal in colour in the future or turn it into a digital-only edition. Maybe this is something to be discussed.
- (2) Acquisition of articles is an on-going work for me. I struggled up to the last minute to find contributors to write and was only lucky enough to get enough articles to publish for this issue. I would appreciate if board members could spread the words or suggest names of potential writers.

ARMTA Provincial Database Report

I have continued to help members with login problems & other database issues.

Since April 2015 we have been using a membership management system for storing our provincial member's information called Member Find Me (MFM). www.memberfind.me In August 2016 Member Find Me changed its name to Membership Work (MW)s: https://membershipworks.com/ Everything else about it is the same. This is a subscription based service that is currently \$79 USD/ month. The benefit of using a subscription based, non-custom, system is that Membership Works will continually be upgraded to meets the need of many users. We pay a small amount every month rather than a huge amount every few years so our system will not get outdated & not need rebuilding from scratch every few years.

The old database is still intact if we need to access any information that was not transferred over to the new system.

Some main features of Membership Works:

- online payment of membership fees
- mail integration with MailChimp to send formatted emails with new members being automatically subscribed to the mailing list
- our find-a-teacher page includes a map with specific locations of teachers clearly marked
- members can create directory profiles witch include photos, links & any descriptive text they would like to include (like a 1 page website for every teacher of ARMTA).
- online payment for our ARMTA events
- · member's only pages on our website

NEW this year: Printable Membership Cards

We now have a printable membership card in the member's area. If you login to the member's area & click on "manage profile" you will find your membership card. There is a print button to print the card.

Admin Access:

Any branch can have a Branch Admin set up to gain access to their Branch member's information & set up events for registration & online payment. So far Calgary, Edmonton & Red Deer branches are making use of this. If your branch would like admin access, contact web@armta.ca.

The ARMTA Provincial Piano Competition is being held in Red Deer on Saturday, November 26, 2016 at Gaetz Memorial United Church, 4758 Ross St, Red Deer. The winner of the competition will be offered the opportunity to perform their repertoire in various locations throughout Alberta as the CFMTA Alberta Young Artist. In the event the first prize winner is unable to participate in the Alberta Young Artist Tour, the second place winner will be given the opportunity.

As convenor of the CFMTA Young Artist for Alberta, I am looking for three branches to host recitals. The responsibilities of the branch are outlined fully in the attachment above.
