- 6. NEW BUSINESS: There were two Motions to be voted upon.
- a. Motion: "To create a Bursary for members of the Executive to cover Registration fees to relevant conferences and workshops such as MTNA." Moved by Lisa Kiernan, Seconded by Chrysanthema Pashunkova. Discussion ensued. Noted that all members of the Calgary ARMTA Executive are on the Endowment Board, and must keep strict arms length away from any disbursements such as the current \$500 bursary for all other ARMTA members. This Bursary would come from the General Account. Would need to further check our Bylaws. Lisa **TABLED** this motion.
- b. Motion: Re Quorum at General Meetings: "(a) A quorum for the business of a general meeting shall be 7 (seven) percent of the total membership as calculated on February 28th. (b) In the event that a quorum is not present 15 minutes after time called for the meeting, the business of the meeting shall stand adjourned for one (1) hour. The members will be notified electronically immediately and given that hour to be present. Quorum at the continued meeting will be whoever is present. Moved by Nathene Arthur. Seconded by Lisa Kiernan. Discussion. We will continue to explore other ways to encourage members to attend GMs, including ZOOM, other electronic methods. Moved by Elaine Case, Seconded by Rita Thurn to AMEND the motion to read as follows: "(a) A quorum for the business of a general meeting shall be 7 (seven) percent of the total membership as calculated on February 28th. (b) In the event that a quorum is not present 15 minutes after time called for the meeting, the business of the meeting shall stand adjourned for one (1) hour. The non-present members will be contacted and the meeting will proceed after sufficient numbers of proxies (or members) have been obtained." CARRIED,

#### **Honours Recital Committee**

Pre-sign-up phase: after a systematic search found Temple B'nai Tikvah venue, contacted director for rental, received board approval to rent, had meetings with and assisted Lisa Kiernan (VP) (reviewed categories, online sign-up procedure, worked with Lisa, Barb and John Robertson (IT) on online forms.)

Assisted with program advertising, emails and phone calls to teachers for donations, liaised with potential advertisers; reviewed document used for sign-up, reviewed online sign-up form. Sign-up and selection phase: assisted Lisa in prize winner selection using Excel, checked winner qualifications.

Organized Performance day: volunteers given responsibilities, co-ordinated with food conveners, program distribution, front desk sign-in, photographer duties, checked for hall set-up, take-down and clean-up, phone calls for refreshment requests to participating teachers, distributed programs, took care of needs as arose.

Post performance: when photos ready, sent and re-sent via email photos to those parents who paid \$5 for group shots. Service provided for free by photographer Ian Mark. Raised \$135 toward next year's recital expenses.

#### **Calgary Children's Festival**

#### Workshops/Events Beth Olver

Since March 2017 Calgary Branch has hosted 2 workshops:

- 1. Magda Adamek 2017 May 7 on the subjects of teaching good tone production and on collaborative playing. There were 20 teachers present including 4 non-ARMTA members. Magda did this workshop in Edmonton & Lethbridge too, and ARMTA provincial provided a \$250 supplement to support this workshop, the venue fee was \$100, and the clinician fee was \$300 (2 hours). The total cost to the Branch was \$110.
- 2. Tina Thrussell 2018 January 14 on the subject of Mindfulness. There were 26 teachers present including 2 non-ARMTA members and 4 students of an ARMTA member. The venue (Lipnicki Fine pianos) was free, and the clinician fee was \$350 (3 hours).

The workshops were free for Calgary Branch members, and \$10 for non-members. The workshops bring out some members who do not come to business meetings.

Here are some suggestions for the next convener:

- for April-May, or late summer, a panel discussion or coffee party on "growing your studio" or "attracting new students". It could include a display of sample registration forms and business policies. This is likely good for an hour, so it could be planned with something else to fill a morning.
- Work with Royal Conservatory regional representative for Alberta, Derek Chui <u>403-613-9367 derek.chiu@rcmusic.ca</u>. The branch may choose a topic (maybe string or voice or wind), Derek can identify a Royal Conservatory clinician. There will be a fee negotiated. Skype or other may be used.
- In the fall of 2015, we held a composer showcase in which Alberta composers were invited to showcase one composition at a recital event. Participants wanted to do this again.

## **South Students' Recitals Carol S. Moore**

There have been three recitals in the past year; May 6, 2017; November 18, 2017, and January 13, 2018. The length of the recitals varies from fifty to ninety minutes, with numbers of entrants varying from twenty-two to twenty-six performers.

Many of the performers are pianists; with one duet performance. We have been privileged to hear vocalists, a flutist, violinists and young children playing the ukulele. Many teachers enter students consistently, with a total of twenty-two different teachers involved this year.

It has been wonderful to listen to all the talent; some performances brought back memories of professional concert presentations. We are fortunate to have so many amazing music teachers in Calgary.

#### Piano Pedagogy Group Advisor Katrina Thompson

I began as advisor for the PPG group in June of 2018, taking over from Alicia Romero. I met with the PPG President and Vice-President in August 2017 to plan our year.

Meetings were held in Sept. 2017, Oct. 2017, Nov. 2017, & Jan. 2018. Meetings are planned for March, April, May, and June of 2018. PPG held their annual student festival in Feb. 2018 with Eric Nyland as their adjudicator. They are planning a fundraising gala for May 2018 to raise money to subsidize conference attendance. The gala includes a performance, reception, and silent auction.

Attendance at meetings is typically 7-10 members. I would like to encourage ARMTA members to promote this student teacher group and invite new teachers to attend a meeting to check us out. Any ARMTA member who feels they might have something to share with the group is more than welcome to present at a meeting. I am open to topic suggestions!

For the 2018-2019 year I will be sharing my role with Carrie Kalmykov as I am expecting my 3<sup>rd</sup> child.

## ARMTA Board Representatives Melodie Archer, Nathene Arthur

It has been a great year to join this position. I would firstly like to thank Melodie Archer (Board Member #1) for her great example and her wisdom in helping me navigate through this. I attended the Fall 2017 Provincial Board meeting in Red Deer, and then the AGM there also. I met the other delegates from across Alberta, and took part in the discussions, motions, voting, etc. I brought back the Calgary ARMTA members Awards for those who were unable to attend those this year in Red Deer. I receive the Provincial emails and have served as a liaison between Calgary ARMTA and Provincial.

We are currently preparing for our Board Development workshop in March in Edmonton. There is so much history to ARMTA, and so many inspiring teachers who have contributed to the many things we do.

I also would like to thank Beth Olver for her "catches" when in my new-ness I mistook something for something else (more than once). She always gently corrected me and pointed me in the right direction.

## CFMTA Delegate Beth Olver

Beth Olver and Marlaine Osgood attended the CFMTA board meeting that was held in Baltimore March 21, 2017 in connection with the MTNA CFMTA joint conference. In July an additional electronic meeting was held to receive provincial reports, any updates to committee reports, financial reports and to approve the budget.

- The Personal Insurance Company has withdrawn its annual support of the CFMTA National Piano Competition first place award (\$6000 accumulated over 2 years for the \$6000 first prize). The CFMTA executive moved "That CFMTA/FCAPM withdraw \$6,000 from the Special Projects Fund principle, in order to provide money for the 1st prize for the 2017 Piano Competition in Baltimore."
- Each year \$2 of each member fee goes to the Special Projects Fund which is used for awards and competitions. For 2019, first prize will revert to \$5000 and be taken from the Special Projects Fund.
- The Personal retains its arrangement with CFMTA that members receive discounted rates on home and auto insurance.
- The winner of the CFMTA Piano Competition 2017 was Paul Williamson (Manitoba). Alberta's **Louisa Lu** was awarded the Willard Schultz Prize for "most promise overall as a performing artist".

Members were surveyed about receiving the magazine digitally in the spring of 2017 and will be surveyed again in 2018.
- The ARMTA resolution "That as a professional courtesy, the CFMTA encourage each branch of Registered Music Teachers' Associations to pay appropriate SOCAN fees (purchase \$35 licenses) in support of composers and publishers." was defeated.
- CFMTA secretary Cathleen Gingrich has resigned. Anita Perry has been appointed in her place.
- The 2017 biennial conference was held in Baltimore as a joint CFMTA MTNA conference commemorating the joint conference held in Toronto in 2007. As promised, MTNA rebated \$3,912.66 CAD to CFMTA for the 29 registrants from CFMTA. Of this amount, 60% has been forwarded to the provinces based on the number of registrants from each province. Alberta received \$414.92.
- Next CFMTA conference will be hosted by Manitoba RMTA in Winnipeg July 3-6, 2019.
- CFMTA has experienced a financial loss of approximately \$50,000 in the past four years. Treasurer Lois Kerr has been looking ahead and making plans to offset these losses. This includes a fee increase of \$5 per member for 2018-19 budget, for a total CFMTA fee of \$35 per member.
