vi. Financial report

ARMTA is in sound financial position.

The GIC 4 for 11,547.66 is currently invested at 0.95% but will renew for 4.7% on February 26th. The GIC for 10,295.22 and GIC 5 for 12,848.20 will both come up for renewal in May 2023. The higher interest rates will earn a larger amount in interest for the next few years.

Our spending for the current year is well under budget, with a \$20,052.68 difference between the \$18,208.00 deficit that was budgeted and our actual spending. Instead of a deficit, we currently have a \$1844.68 surplus but there are still some expenses to be paid out before the end of our year on March 31st. The only larger expenses that are anticipated are the Voice Competition, Piano Competition, and service fees.

There are two items the board should be aware of for the future. CFMTA has increased their fee from \$37/member to \$42/member. The board approved not raising fees for the 2023-2024 year when this will begin to take effect. When the board decides to raise fees, it will have to be approved at the AGM in October before taking effect the following membership year.

CFMTA has voted to raise the cost of their magazine print copies from \$20/year to \$35/year. This includes three publications/year and will take effect 2024-2025 year but should not impact ARMTA's budget because this cost is only for members who chose to order the print copy and the increase will be passed onto them. The digital copy remains free to all CFMTA members.

vii. Administrator's report

Since September, I have worked on memberships (renewals, new applications, reinstatements, leave of absences) updated the directory, answered emails and communication on a daily basis, prepared documents/budgets for the board meeting, prepared the milestone awards, helped organize the AGM, sent out the monthly newsletters, paid bills and maintained accounts with proper record keeping, provided contracts for adjudicators and clinicians, supported publicity and advertising with posts on Social Media and mailing posters for the Competitions to Universities and Conservatories, emailed members who have a Vulnerable Sector Check expiring and updated their file.

When I was hired in July 2021, my understanding was that the wage was for an average of 40 hours/month. This job does have seasonal hours which is understandable. You can see from Vicki's hours that between 2013-2021 there were only two years that averaged 40 hours. The last three years, 2019-2021, the average was 45 hours per month. I expect my hours to be reduced some this coming year; however, an average of 45 hours is probably more realistic.

According to Alberta Alis, the starting average wage for an administrator is \$25.89/hour. https://alis.alberta.ca/occinfo/wages-and-salaries-in-alberta/administrative-officers/1221/

Following those two considerations, I'm proposing to the board that my wage be increased to be more congruent with the hours required to complete the job.

ii. Bursary and Scholarships

From September 2022 to February 2023, the Committee assisted 7 students with bursaries for music studies, totalling \$3200. Families write about experiencing financial pressures and the increased cost of living, making it difficult to continue music lessons. Families are expressing gratitude for the bursaries, as well as teachers. The wording on the website was adjusted as the Committee was finding that more background information from the parents was required. For students under 18, the Committee requests a copy of a letter from a parent or guardian, describing the financial situation and reason for applying for this bursary.

The Committee received a request from a family that had recently arrived in Canada from the Ukraine. As there is a requirement that students are in Canada for a minimum of 6 months before applying, the Committee brought this request to the Board, and was able to assist this young student with a \$500 Bursary. Currently, the Committee is in discussion regarding the possibility of a Refugee Bursary Program.

The Bette Joan Rac Scholarship was awarded for the first time in 2022, to Sam Saghaei Zefreh. The Committee received 14 applications for this scholarship. The deadline for this scholarship has been moved to June 30th of each year.

In February, discussions began with a potential scholarship donor. As this develops, information will be brought to the board.

iii. Bylaws/Policies and Procedures

There have been questions about the relationship between the Provincial ARMTA Board and ARMTA Branches (email Nov 8, 2022). Should the branches submit their annual reports to the Board? Do Branches have bylaws or Policies and Procedures?

Proposed amendments to Policy and Procedures:

Administrator Treasurer description add:

Administrator shall request annual financial reports, auditor reports and AGM minutes from each Branch. ARMTA is registered with Alberta Corporate Registries, and the branches receive their authority to operate from ARMTA (provincial). The branches cannot register independently. ARMTA (provincial) is ultimately responsible for the finances of the branches.

Replace XIV. BRANCHES (orange text is detail for the board to decide)

XIV. BRANCHES (remove, this is in the Bylaws)

- 1. A Branch shall be an association of no less than five voting members, who reside in the same vicinity, who may elect their own officers and set their own fees.
- 2. Branches shall elect one Board Member for every 100 Branch members to serve on the ARMTA Board of Directors.
- 3. Members wishing to form a Branch may apply to the Provincial Administrator who shall submit the application to the Board for approval.
- 4. Branches shall meet together for the purposes of artistic, professional and educational enrichment.

(add)

- 1. ARMTA branches operate under the registration (Alberta Corporate Registry) and bylaws of the Provincial ARMTA Board.
- 2. Annually and at the request of the administrator, each branch shall provide copies of financial reports, auditor reports and AGM minutes to the Provincial Board for their records.
- 3. A Branch shall be an association of no fewer than five voting members, who reside in the same vicinity.
- 4. The branch should have its own Policies and Procedures Manuel, elect officers, and set their own fees.
- 5. Branches shall select one Board Member for every 100 Branch members to serve on the ARMTA Board of Directors.
- 6. Members wishing to form a Branch shall apply to the Provincial Administrator who shall submit the request to the Board for approval. The application should include the names, addresses and ARMTA membership status of those wishing to form a branch (minimum five members)
- 7. Members of a Branch may meet for the purposes of artistic, professional, and educational enrichment

Provincial Administrator

GENERAL DUTIES: The Secretary Red is text that is added

- 1. Presents a complete report of administrative activities at each Board meeting.
- 2. Coordinates with the Newsletter (Tempo) Tempo Layout and Design Editor and assists in the distribution, including:
 - a. Two copies to the National Archives

- b. One digital copy to Archivist of CFMTA
- c. Two copies to ARMTA Provincial Archivist
- d. One copy to each advertiser
- 10. Books the room for in-person Board meetings and arranges for coffee and lunch services.
- 11. Arranges and distributes zoom links for online meetings.
- 15. Keeps a record of the list of members reaching milestone years. Notifies the President of those who have achieved milestone years and asks the Vice-President to invite those members to be present at the Annual General Meeting for recognition. Milestone years are reached at 25 years and every five years after that. Recognition of milestone years are acknowledged with the following:
 - 50 years: gold ornament engraved with the current year on the back A medium sized glass award
 - 40 years: pewter ornament engraved with the current year on the back. A small glass award with members name, current year and ARMTA logo
 - 30 years: an ARMTA coaster—A keychain with ARMTA logo on the front and members name engraved on the back
 - 10, 15, 20, 25, 35, 45, 55, 60, and 65 years: a certificate. Certificates will be unframed.
- 16. Organizes the AGM with the assistance of the President, Vice President, and Past President
- 17. Ensures each new convener and each new board member signs the confidentiality agreement. Keeps signed confidentiality agreements on file for 50 years after their term of office.
- 18. Keeps track of vulnerable sector checks for every member and sends notice to members who are due to renew their vulnerable sector check.
- 20. Does not allow members to renew unless their VSC has be updated to within the last five years.

There was a question about **reimbursement for accommodation** for Board members attending a meeting

Under Policy & Procedures part VI MEETINGS - Meeting expenses reimbursement (c) ACCOMMODATION expenses which currently states

Meeting Expenses Reimbursement

- 1. For a regular Board meeting, Board members who are traveling from out of town, will be reimbursed for:
- (a) TRAVEL expenses to and from a Board meeting to a maximum of the equivalent of the return bus fare at the time the expense is being claimed, based on $\frac{3.35}{5.61}$ per kilometer.
- (b) MEAL expenses while a Board member is attending a regular Board meeting on the basis of receipts to a maximum of \$50 per day.
- (c) ACCOMMODATION expenses for one night at the most economical rate if distance is over 350 km 295 km one way, unless ARMTA pays the hotel directly.
- (d) Under special circumstances, Board Members may be reimbursed for meals and a second night of accommodation.
- 2. Board members attending a Board Meeting which takes place at the Annual Conference or other special gathering of all members shall be reimbursed for their travel expenses and two day's meals and accommodation

The board should determine under what circumstances accommodation is covered for board members.



- The history is that one-day meetings were held in person in Red Deer in February and in the Fall
 (especially if fall the conference was in Red Deer). It was felt that members travelling from Edmonton or
 Calgary or closer had about a 2 hour or less drive and it was reasonable to drive both ways and attend
 the meeting all on one day (Saturday). Those from further away were provided accommodation for one
 night.
- With in person meetings now held in different locations and online presence at meetings now common, the Board should determine what is fair (in terms of accommodation and other expenses) and what removes barriers from attendance at meetings, especially if in person is to be encouraged.

Erik Horne was asked by the board after the last meeting to create some Financial Review Procedures to help members who are auditing who have not previously had experience reviewing the books.

- What an excellent guide for auditors! I hope it will be made available to the branches who will have to change some specific references to match their situation.
- There are no directions for auditors other than Policy & Procedures part X Revenue and Finance point 1 which states "The fiscal year shall be from April 1st to March 31st. The books and accounts of ARMTA shall be audited by a qualified accountant or by two members of the Association elected for that purpose at the previous Annual General Meeting. A copy of the audited financial statement shall be available to all members at the Annual General Meeting."
- I suggest making the Financial Review Procedures document prepared by Erik Horne
 - o become part of Job Descriptions and in a new section for Auditors.
 - o and a separate document located on the website with the Bylaws and the Policy & Procedures documents.
- The Policy & Procedures part X Revenue and Finance point 1 could be revised to state:
 - "The fiscal year shall be from April 1st to March 31st. The books and accounts of ARMTA shall be audited by a qualified accountant or by two members of the Association elected for that purpose at the previous Annual General Meeting. If two members carry out the audit, they should follow the Financial Review Procedures document found on the website in the member's area and in the Policy and Procedure manual under Auditors. A copy of the audited financial statement shall be available to all members at the Annual General Meeting."

VIDEO INTERVIEW SERIES ON TEACHING

Plans to begin the teaching interview series in Fall 2022 were delayed until Spring 2023 after I met with the technical assistant (a recent U of L Digital Audio Arts graduate turned freelancer) who would shoot the footage, edit, provide a uniform look to the series and add ARMTA branding etc. For each of the 8 interviews, the plan is to create a 45–60-minute podcast version (full interview), 15-minute video (edited highlights from the full interview), and a short snippet for social media marketing.

This is a big job for one individual and therefore more expensive than what I originally budgeted for technical assistance. To alleviate extra costs, we will add 2 or 3 students either in Digital Audio Arts or New Media who will work for Applied Studies credit. They will do a good portion of the editing work for course credit, organised and overseen by the technical assistant, and I will supervise the academic credit side. Timing for Applied Studies is correlated with semester dates, so they will come on board for the Summer 2023 semester. Total cost will be \$600-800 for the technical work, with some coming from the 2022-2023 budget for two or three interviews, and the rest coming from 2023-2024.



Each of the interviewees will receive a \$250 speaking fee.

What versions of the series you would like to have publicly available, if any (e.g. social media shorts and 15-minute videos?) and what versions should be members only, if any (e.g. long form podcast?) Or should all be available only for members? Or should all be available publicly?

The balance of the ARMTA Recognition Fund as of January 31, 2023 is \$55,119.47

This year there were 3 donations: Rusconi Fund (Edmonton Community Foundation) \$21,703. It was received in April of 2022. In the past, the Rusconi funds have been distributed in October. ARMTA Provincial honored 2 members with donations:

- Nathene Arthur for her service as ARMTA Provincial President
- Marlaine Osgood, ARMTA Service Award 2022
- There was a general Provincial donation of \$95 which was a cumulative amount from several members who overpaid fees and chose to donate rather than get a refund.

Since January, I contacted 15 recipients of awards/bursaries of \$500 or more on behalf of Lois Kerr, the Treasurer of CFMTA. The auditor of CFMTA Trust Fund recommends that all recipients of amounts greater than \$500 be sent T4a forms and report these amounts on income tax. In the future, information required will be requested as soon as the cheque is sent – not as a large group at the end of a year.

I enjoyed hearing from Branch Awards Convenors, Christine Rogers for the Student Composer Competition, and Lorrie Wittke regarding Bursaries and awards. Generally, the year went very smoothly with a relatively few cheques not being cashed in a timely fashion. It is evident that many young people are not as comfortable using a cheque as they are using electronic banking.



I believe that my September 2022 report and the ARMTA Recognition Budget report covers the rest of the information for the past year.

Special thanks to Tamara Bowie who really is an "administrator extra-ordinaire". I do appreciate the work that it requires to serve on the Provincial Board and I am grateful.

ARMTA Recognition Fund Scholarship February 2023-24 Budget Recommendations

Report to ARMTA Provincial Board Feb. 2023

The current balance of the ARMTA Recognition Fund is \$55,119.47. The Rusconi Fund Donation in October 2022 was \$21,703.00 again above the previous year. It is evident that the Edmonton Community Foundation invested the Rusconi money very well and it has been secure even through the financial stresses of a pandemic and global financial crises.

Just for review, this fund in its inception in 2008, was created with ONLY the provincial biennial piano competition in mind. The board at that time hoped for \$5000 every 2 years. ARMTA should be so proud of what the fund has been able to achieve because the Edmonton Community Foundation chose ARMTA for the Rusconi family's donation in memory of the late Ethel Rusconi (nee Weisbeck) a past ARMTA member from Medicine Hat. The balance, even after the July 2023 competitions, will be comfortable and the board does not need to be afraid to tap into it when a worthy project comes up. 

Since April 2015 we have been using a membership management system for storing our provincial member's information called Membership Works (MWs): https://membershipworks.com

This is a subscription-based service that is \$948 USD / year (\$79 USD per month) this year & will increase to \$1140 USD / year (\$95 per month) starting January 2024.

I have been making changes & updates to the membership registration form, events & other areas of our Membership Works system as instructed by the administrator & event coordinators.

I have continued to help members with login problems & other database issues.

I have assisted the administrator with customization & issues that arise with our Membership Works account.

Reminder: only members with a current VS check will in included in our public Find-a-Teacher directory page.

Provincial Executive Label:

Reminder: Members who are part of the provincial executive have had a label added to their account so they can access the "Exec only" tab in the member's area of our website. If you are on the provincial executive, you will automatically have access when you login to the member's area with your usual email & password.

Admin Access:



Any branch can have a Branch Admin set up to gain access to their Branch member's information & set up events for registration & online payment. Calgary, Edmonton & Red Deer branches are making use of this. If your branch would like admin access contact web@armta.ca.

Event List:

Any branch can post their events in Membership Works so members can register online (offline & online payment options available). Membership Works keeps track of registrations & payments received. You can put the registration form right on your own branch website.

i. Calgary

Our ARMTA Calgary Board members live in various suburbs of Calgary, as well as in Cochrane, Airdrie, Strathmore, and near Okotoks. Zoom meetings have made it easier to meet. We continue to be supported by our Administrator Maryellen Pankratz.

We have had some changes in our Board in recent months with our Chair resigning and our Co-Chair on leave. Beth, our Past Chair, has been transitioning to Acting Chair. Under her leadership the board will be hosting March Madness House Parties; four house parties, two in-person and two virtually to engage and revitalize our membership. The Calgary Branch Board will be working hard for our upcoming AGM on May 8th, 2023 ACRA (ARMTA Calgary Recitals and Awards) is an exam mark-based recital, and our ACRA Convenor Naomi Williams did an amazing job organizing this in-person event held in January 2023. The Endowment Society of the Calgary Music Teachers' Association awarded \$2580 in scholarships to 37 winning students and the Provincial Recognition Fund contributed \$1500 to an additional 12 students, for a combined total of \$4080 paid out in student scholarships.

Students of ARMTA Calgary members who received over 85% on their practical exam and completed the theory co-requisites but didn't make the top three marks for their category were invited to perform at this recital. All the participants received certificates and students with marks 90+ received a medal in recognition of their outstanding achievement. In addition, a 3-member jury chose 8 participants to receive cash scholarships based on their performance. Group photos were taken of the participants and the scholarship winners.

ARMTA Calgary hosted its Inaugural Adult Student Recital in February 2023. To celebrate Valentine's Day, the theme "Songs of Love" was chosen. The event was held at Asylum for Art in downtown Calgary on Sunday February 12th at 2 pm. The venue sold cocktails, coffee/espresso and food. Spouses, partners, family and friends were encouraged to attend. Special thanks to Kaylee Read for spearheading the event.

Two additional May recitals are being held to provide students of ARMTA Calgary teachers performance opportunities: a Calgary Branch North Student Recital and a Cochrane Student Recital.

The ARMTA Calgary Endowment Society has announced its Second Annual Poster and Video Competitions to follow-up on last year's successful launches. Students of ARMTA Calgary teachers are invited to submit an original poster or original creative video that represents a piece of music or speech arts selection that they are studying or have recently studied.

The ARMTA Calgary Endowment Society also announced its first Dual Excellence: Teenage Superstar Award. The annual award is for teenage students who demonstrate a high level of accomplishment in two disciplines: A One ARMTA discipline and one secondary discipline or two ARMTA disciplines Accomplishments will be determined through an application process, including performance requirements.

The entries in all three competitions will be submitted in one of two age categories:12 years and under and 13 and over with cash prizes awarded for 1^{st} , 2^{nd} and 3^{rd} places and honourable mentions at the discretion of the judges. Thank-you to Nathene Arthur, Carolyn Steeves and Laura Whitehead for taking a leadership role and to Lorna Sewell and Maryellen Pankratz for their contributions.
