iv. CFMTA report

The CFMTA Bi-Annual Directors and Delegates zoom meeting was held online Saturday February 3, 2024.

As the ARMTA Provincial Past President, I serve as 1st Delegate and attended this meeting. I would like to share the following relevant-to-ARMTA notes I took today:

<u>1</u> The CFMTA bi-annual "National Music Competition" Task Force has created two options for moving forward after the piano-only 2025 Conference in Montreal. One option is to have a multi-disciplinary competition open to piano, voice and strings; the second option is to have multi-disciplinary option open to all instruments, voice, speech arts etc., that encompass what our CFMTA members teach. Each province could hold their own competition and could elect to

send up to THREE finalists of their choosing to the CFMTA finals. Does ARMTA have any feedback on this for CFMTA before their March 15th deadline from the provinces/territories?

- <u>New deadline for 2025 CFMTA PIANO COMPETITION</u> entries is March 1st, 2025. We will need to begin advertising our Provincial Piano Competition and choose our winner before that date.
- <u>**Onations.**</u> CFMTA would welcome donations towards the 2025 CFMTA National Piano Competition from provinces, branches, and individuals. Danielle McIntyre is the current Convenor. Do we have anything in the budget for this?
- <u>4 CFMTA Poster Competition.</u> Very few entries, so this would be good to promote across Alberta once again.
- <u>CFMTA Essay Competition.</u> Donations needed by May 1st, 2024. There is a High School category, so if anyone knows of a strong High School Music program, please let me know and I can add them to the CFMTA Essay Competition contact list. This will enable our CFMTA Convenor to contact the school directly with information, application forms etc. This competition is still seeking donations, \$1500 is collected, and needs another \$1,000 by May 1st.
- <u>6 Eligibility to apply for CFMTA Competitions.</u> With the exception of the Essay Competition, all CFMTA competitions will be open to "Canadian citizens and legal residents of Canada." Please note that new wording/clarification for our Provincial entries to CFMTA competitions.
- **Young Artist Tour.** A task force has been struck to look into helping this program out. This tour can occur anywhere from Fall of 2024 to late Spring of 2025. Another idea was to somehow include a national YA Tour as part of the winners' packages for the CFMTA's National 1st place winners. Thoughts? *And I will contact Rosemarie Horne about her taking part on this task force.**
- <u>8 Branching Out.</u> So far only two entries are in. Two more are expected. Prizes are \$100 each up to the first six entries, and then there is a draw if there are more than six. Deadline to take part is March 15th. Deadline to send in: March 31st. The year 2024-2025 theme is: "Choose Your Own Adventure" for each branch to bring music into our communities and benefit them (while also showing some provincial team spirit). Some ideas brought up were "Serenade a Senior", going to an Ice Cream Parlour, etc. Possible to also make it more of a provincial/territorial theme for us like something at the Calgary Stampede, Klondike Days, while hiking in the mountains, etc. Singing at a ranch? Alberta animal theme? Thoughts?
- **9 CFMTA "Of Note" will need a new Editor.** This is a paid position., \$150 per issue (monthly). Requires some tech skills, plus someone who keeps well ahead of CFMTA news and events. Preference to a CFMTA member, with a skill for both communication and fun.
- <u>10</u> <u>Program Funding and Grants.</u> In addition to fundraising through "Grant Advance" and the online CFMTA "Honour Your Teacher" link, we are asking all members of CFMTA to reach out to those among their students, parents, and organizations with whom they have a relationship, whom they can contact directly. This third method of fundraising is actually very successful. Please let the people in your own acquaintance know about CFMTA and our

fundraising for the bi-annual Conferences, National Music Competitions, Essay/Poster/Student Composer competitions, Scholarships etc., which they may want to consider donating to?

11 CFMTA "Canadian Music Teacher Magazine". I did mention that ARMTA is considering another "Resolution" to be presented regarding the almost-doubled cost of the hard copy magazines. CFMTA meets again July 3, 2024. So, our Resolution, should we decide to make one, would need to be sent in no later than May 3, 2024. Discussion?

Those are the notes I highlighted to share with ARMTA Provincial at our February 2024 meeting.

If you have any other questions about CFMTA, I would be happy to talk with you.

Provincial Life Membership: At the last board meeting, the board asked me to find more information and provide an analysis of Provincial Life Membership costs.

This item was brought up because I had questions about the wording in the Policy and Procedure manual. Does a member become a Provincial Life member after 50 years AND retired? I have since found the answer in the minutes from 2017 when it was created.

" Minutes October 26, 2017 board meeting.

Life Memberships for 50 plus year members

Amended Motion: That Life memberships be granted to retired members who have reached 50 years as RMTs.

Moved: Nathene, Melodie

Discussion: To give life membership to all 14 members would cost \$35 for insurance plus \$35 for CFMTA membership, a total of \$980, plus we would no longer be receiving their membership fees, which makes this an almost \$3000 decision. To give free memberships to retired members would only cost \$35 for their CFMTA memberships and only applies to 2 current members. This allows them to continue to receive the CFMTA magazine and ARMTA newsletters to stay in touch with the music community.

All in favour MOTION CARRIED"

We currently have 17 members that have been members for over 50 years. 7 of those are retired and therefore are Provincial Life members. To give Life memberships to members before they are retired (10 members) would cost ARMTA approximately \$1800/year.

vi. Financial report

ARMTA is in sound financial position.

Our three GIC's totaling \$35,176.88 are invested at the fabulous interest rates of 3.7%, 4.55%, and 4.6% until spring 2026. Our spending for the current year is well under budget, with a \$14,299 difference between the \$23,608 deficit that was budgeted and our actual spending. There are still some expenses to be paid out before the end of our year on March 31st.

The balance sheet shows the financial position at a point in time. During the pandemic, the balance of our operating account rose because of reduced expenses. Therefore, the board voted on a deficit budget to reduce our account balance for the last few years. As you can see from the balance sheet, our general account balance is going down. We still have enough funds to sustain a deficit budget for a few more years if the board chooses to.

If/when the board wanted to raise membership fees, it would take effect the next fiscal year because it needs to be voted on by the membership at the AGM in October. Our last membership increase was in 2020 for the 2021-2022 membership year when fees were

increased by \$20 because of an increase in insurance cost. In 2022, CFMTA increased their fees by \$5 but ARMTA did not raise fees at that time.

If fees were raised by \$5/member, it would increase our membership income by \$2330. Fees raised \$10/member would increase \$4660 and a \$15 increase/member would result in approximately \$7000 more per year in membership income.

ii. Bursary and Scholarship

From June of 2023 to February 2024, the Committee assisted 6 students with bursaries for music studies, totalling \$2,700.00. Families write about experiencing financial pressures as they strive to provide extra-curricular activities for all their children. Accessing assistance for the cost of music studies for their child has taken some of this pressure off and made it possible for lessons to continue. Families are expressing gratitude for the bursaries, as well as teachers. Some responses I have received from parents:

Thank you very much for such a quick and favorable review.

This kind support from ARMTA Bursary will help to meet (child's name) need in her continued development.

We are very grateful for this timely help for our condition.

Wow, that is amazing! Thankyou very much Lorrie, this is incredible news for us, it is greatly appreciated.

At the time of writing this report, there are 2 applications that are in the process of being reviewed for a Needs-Based Bursary.

For students under 18, the Committee requests a copy of a letter from a parent or guardian, describing the financial situation and reason for applying for this bursary. Receiving parental input is very important as the Committee makes their decisions. Occasionally the committee needs to reach out to a parent or guardian and request clarification on the financial need. The committee is currently waiting on the completion of one application for a needs-based bursary.

The Committee received the first Newcomer Bursary application and was pleased to assist a student that has recently arrived in Alberta.

The Bette Joan Rac Scholarship was not awarded this year. Unfortunately, there was only one application, and the proposed plan of study did not qualify for this particular scholarship. The committee will look at some options as they receive applications for the May 31st deadline. For example, one option could be to give two \$1000 scholarships.

The first recipient of this Scholarship was Sam Saghaei Zefreh. I was very pleased to hear of his continued study and performance. Sam has received a Scholarship in the Calgary Performing Arts Festival, as well as a Gold Prize in the Up and Coming Star category of the Amadeus Awards in 2023. He has also participated in the Rotary Calgary Concerto Competition, and was the winner of the 22 and under Piano Class at the 2023 Canada West Performing Arts Festival that was held in Edmonton in July. ARMTA sponsored this class. He has been accepted in the Bachelor of Music in Piano Performance at McGill.

Two Pedagogy Scholarships were awarded- Kathleen VanderPloeg and Erin Hiebert each received a \$1000 Scholarship towards their music studies. The committee received six applications for this scholarship.

The Continuing Education Scholarships were awarded to two members. Rose Schmaltz received \$1000 towards her flute studies, and Kaylee Read received \$500 towards her vocal studies. The committee received three applications for this scholarship.

The Betty Phelan Memorial Scholarship will be awarded for the first time in 2024. The Betty Phelan Memorial Piano Scholarship, initiated by Carol MacKinnon-Hagan recognizes and honours Betty's life and her dedication and commitment to the music community of Edmonton. Betty, as a well-known piano teacher in Edmonton taught hundreds of students over her nearly 60-year career. This is a needs-based scholarship.

As I have recently stepped into the position of Convenor of the Recognition Fund, the Bursary and Scholarship Committee has been divided into two separate positions. I will continue on as the Convenor of the Bursary Committee, and Ida Edwards will be stepping into the Convenor position for the Scholarship Committee.

Breaches of Code of Ethics: a procedure to follow when there is a complaint

ARMTA's policies regarding non-discrimination are included in our Policy and Procedure Manual under the Code of Ethics, the CFMTA Code of Ethics, in our Policy and Procedures and Bylaws under the heading Membership, and in our membership application.

Procedure to follow when there is a complaint against a member, board member, or officer:

- The complaint or concern is to be stated in writing and sent to the ARMTA President via the ARMTA administrator (admin@armta.ca; 1114 Cameron Rd S, Lethbridge AB T1K 4B3).
- The administrator will acknowledge receipt of the complaint and ensure the President, or in the case of the President not being available, the Vice President, receives the complaint.
- Within 10 days of receipt of the complaint by the President, the President shall form a panel.

In the case of a member:

The panel will consist of three board members to review the complaint. The President may serve on the panel or may be ex officio on the panel. Potential panel members should declare any bias or conflict of interest.

In the case of a board member:

The panel will consist of an officer and two board members to review the complaint. The President may serve on the panel or may be ex officio on the panel. Potential panel members should declare any bias or conflict of interest.

In the case of an officer:

The panel will consist of an officer, one board member, and one member to review the complaint. The President may serve on the panel or may be ex officio on the panel. Potential panel members should declare any bias or conflict of interest.

- The panel may:
 - Contact the author of the complaint for more information.
 - Contact the member against whom the complaint has been made for that member's view of the problem.
 - Request a written statement from the member against whom the complaint has been made.
 - Interview third parties who may have additional information.
 - Attempt to mediate between the two parties.
 - Review applicable parts of the codes of ethics (ARMTA and CFMTA) and Bylaws and Policy and Procedures of ARMTA.
 - Consult with other board members.
 - Determine whether disciplinary action is required and what the action should be.

- The panel will write a report of their findings with copies sent the ARMTA President, the ARMTA administrator, and the board. The administrator will send the report to the complainant and to the member against whom the complaint has been made.
- The complainant or the member against whom the complaint has been made may appeal the decision. In which case the board will review the decision and determine
 - that the action and report or the panel stands, or
 - that a new panel of ARMTA members (three people who had no part of the first panel's process) be formed and the process followed once and only once more.

vii. Conference

Background

Music Conference Alberta's joint planning committee consists of four stakeholders/co-producers: Alberta Band Association (ABA), Alberta Music Education Foundation (AMEF), Alberta Registered Music Teachers' Association (ARMTA) and Choir Alberta (CA). Choir Alberta has control of the documents and financials.

ARMTA was invited to become a co-producer, and have a seat at the planning table, and in June 2021, we voted in favour of joining the MCA joint planning committee.

As such, we were to sign a Memorandum of Agreement (MOA) and share in the conference costs and profits. (As added information, the 4 co-producers listed above were to become "an independently funded entity that will assume responsibility for managing the conference.")

Following the 2021 online conference, the first conference ARMTA was involved in as a coproducer, we had yet to sign an MOA. We were not given a copy of the financials after the conference.

Following each subsequent conference, we asked for a copy of the financials, but our response was ignored.

After the 2023 conference, ARMTA was approached by AMEF regarding concerns over the lack of communication with Choir Alberta, including the lack of access to the financials.

In January, three co-producers – ABA, AMEF, and ARMTA – sent a letter to the Choir Alberta President and the Choir Alberta Executive Director expressing our concerns and requested:

- -Payment of proceeds from 2021 MCA online
- Finance report and any proceeds from MCA 2022
- 2023 MCA MOU and Budget

None of the 3 co-producers received financials or their share of the profits.

This is still a work in progress, and the three co-producers are hoping to resolve.

CALGARY BRANCH

Keyboard Harmony Presentation with Nita Pelletier and Joyce Janzen November 17, 2023via Zoom

Report of Event:

The Calgary Branch invited all Alberta Branches as well as other music organizations of Mount Royal Conservatory and Alberta Piano Teachers' Association (for a \$25 fee) to attend this presentation via zoom. The response and turnout was reasonable, with about 22 ARMTA members planning to attend. A few on the morning of sent their regrets for not being able to attend. The presentation was recorded in full, via Zoom, and posted on Vimeo for the agreed 10 days following the presentation. This was extremely helpful for those who had registered but could not attend on the day. It was also useful for those in attendance who would want to review the material.

Nita and Joyce have created an impressive resource that covers all three levels of Keyboard Harmony. This resource will be immensely helpful for those teachers wanting to incorporate more of the skill within their studio as well as preparing students for RCM exams in Keyboard Harmony. In the presentation, they introduced the fundamentals of Keyboard Harmony, its significance in developing overall musicianship in our students, and the logical decision to choose

Keyboard Harmony over the written Harmony exams (a: more practical in terms of musicianship, b: less marking for the teacher, c: potential for building more confidence in the student). They shared many strategies and helpful hints on how to begin implementing the material.

They offered a discount on their workbooks for 10 days following the presentation. We received many positive comments from the attendees. And considering that RCM does not have a formal and published resource for teaching Keyboard Harmony, these new workbooks really deserve a place in our teaching studios. We hope to have Nita and Joyce again in the future so that their material can reach more of our membership.

Teaching With Your Whole Self with Dr. Laura Hynes

Location: The Room YYC (COL Studio), Calgary SE

Benefits: learning to improve skills of body/mind awareness, thereby enhancing ability to better

listen and communicate with students

Report of Event:

The first workshop of the year was given by Laura Hynes, an Alexander Technique "teacher in training" who gave the attendees exercises towards body awareness and mindfulness. A few teachers did not attend (given the snow and very cold temperature on the 7th, this was not surprising) with 9 in attendance. The workshop was extremely helpful with specific exercises in: 1) breathing, balancing, and putting awareness to these aspects in physical activities and 2) mindfulness of how we go about physical and intellectual tasks. This was a meaningful introduction to what Alexander Technique offers as a method for body and mind awareness that can help every teacher and student be better, more productive, more comfortable, and enjoy what we do on a daily basis. It is the type of workshop that could (and should) be a regular component of our ARMTA events for teachers and students and I will be recommending this for our Branch going forward.

xiii. Piano Competition

Proposed budget, provincial piano competition 2025

To the board of ARMTA: Please find below my proposed budget for the 2025 provincial piano competition.

This budget is based on my knowledge of the competition after presiding over last year's event. It is also based on my plan to move the competition to Calgary in 2024. No Red Deer members were present in the audience at the final competition last year (thank you to Annette Bradley for the generous donation of her studio as a warm-up space). I hope that by switching venue cities

we may find more willingness among the members to support the performers, and hopefully also find support from the general public.

We have just exited a period of historic inflation. The numbers in this budget represent adjustments for that inflation, as well as new line items. Some details:

- Adjudicator airfare: Last year, we were fortunate to save money by calling upon Dr. Despres within province to serve as adjudicator for the final competition. I will not use an in-province final adjudicator this year as it creates potential conflicts of interest if performers and adjudicators worked together recently. I therefore budgeted for an adjudicator airfare cost based on rough average costs of flights from Toronto. If possible, I will bring an adjudicator in from a closer centre.
- Application fees: many are struggling due to high inflation. I removed the competition entry fee from the budget so that affordability is not a question for students experiencing financial hardship. I also suspect that the \$50 entrance fee is limiting our overall registration numbers, and I feel it is far more important to increase participation in the competition than it is to raise small amounts of money from registrations. Students who doubt the likelihood of winning (which is an understandable doubt in any competition) are unlikely to pay \$50 to enter. We had only four applications last year, even after an email and poster campaign that reached out to every post-secondary music department in the province.
- Tamara Bowie informed me that following her submission of travel expenses from last year, the board decided that in future I must find volunteers among local memberships to save money. Tamara is an important member of my team with whom I communicate about the competition regularly and I rely on her on the day of the competition to keep things running smoothly. Please confirm her travel costs as indicated in the proposed budget.

Upon approval of this budget, I will begin the process of finding and securing an appropriate venue, hiring first and final round adjudicators, and working with Carolyn Garritano to streamline

the online application page to help applicants understand better the requirements/ relationship between the provincial and national competitions, based on feedback from last year's registrants.

xiv. Publicity

Brand refresh at Branches:

- for the 2023/24 budget year, \$500 per branch was budgeted for replacement of obsolete branded promotional material. Three branches requested reimbursement, at an average cost of less than \$300 per branch. Three branches have not yet requested material (Edmonton, Lethbridge, Grande Prairie).
- I suggest reimbursement up to \$300 per branch, for replacement of event banners in particular, plus other material if funds permit. Banners will be produced using a template design commissioned through Publicity budget during original brand refresh, and ordered centrally through VistaPrint.

ARMTA Name Recognition resumed for 2024/25 (assumes appointment of a Social Media Convenor):

The 2024/25 publicity plan is to increase participation in ARMTA events, and increase provincial membership numbers, by publicizing our events and our benefits of membership, and generally creating greater awareness of the ARMTA brand. We piloted this during 2022, with branded promotional posters for Violin, Voice, Piano, and Student Composer competitions plus paid Facebook and Instagram promotional campaigns.

- People must recognise ARMTA branding for any of this to be effective, and branding has
 to be extremely consistent across our programs. For this reason, all promotional material
 should be designed through Publicity.
- Optimally, the Publicity budget will continue to cover promotional material for ARMTA competitions and scholarships.
- On occasion, usually on a social media site, something shows up in contravention of brand standard. If necessary, I'll use funds from the sundry budget to support corrections.
- I suggest that we continue our arrangement with Carol Kemp Creative Direction, for branded designs, and also streamline and economize by entering into a joint subscription to a design software so that Carol can share templates with us.
- the budget for design software is intended for creating streamlined, brand-protected material shared between Carol kemp or any other graphic designer, the future social media convenor, ARMTA Admin, and ARMTA Webmaster. The budgeted amount aligns with current share costs through Canva Pro.

RE: ARMTA Provincial "Bring Out the Brilliance" String Competition scheduled for November 2024 in Red Deer, Alberta

- 1. We have requested \$2,050 from ARMTA Provincial for the running of this Competition, which includes venue, 1st and Final Round Judges, Programs, Certificates, and travel for Committee Reps. This will be brought down to the \$1,500 allowed by ARMTA through the inclusion of Entry fees which we anticipate will be around \$660 for 12 Junior and 6 Senior entries. Junior entry fees are \$30, Senior are \$60 per student.
